Court convicts -'SMUT' photog

BALTIMORE (UPI)—A former National Defense employee was convicted by a federal jury of soliciting Baltimore boys 8 to 18-years-old and photographing them in obscene poses as part of an international pornography business.

The seven-woman and five-man jury ruled that William Inglis, 35, a former computer expert for the Defense Communications Agency, illegally used the mails for distribution of the pornographic pictures from 1975 to 1977.

The jury also found Mr. Inglis guilty of transporting three boys, who were between the ages of 9 and 14, from Maryland to Virgina for prostitution.

The jury, however, ruled Mr. Inglis was innocent of charges that he took two Maryland boys to Florida for prostitution. Testimony at the trial indicated the two children never engaged in sex.

U.S. District Judge Frank Kaufman ordered a pre-sentence report and set sentencing for Nov. 3.

Prosecutors said Mr. Inglis was a key figure in the mail-order pornography business that used Baltimore boys in sexual poses as models for pictures and films. Five people in addition to Mr. Inglis were indicted last May for conspiracy in the obscenity case.

Larry Dunn, 53, and Donald Masken, 38, both of Baltimore, pleaded guilty and are awaiting sentencing. Two of the other indicted men live in Switzerland and cannot be extradited. The fifth, David Hustle, 38, of Baltimore, also has fled the

Parker Smith, Mr. Inglis's defense attorney, said, "I think we got a fair and honest trial and I'm sure Mr. Inglis agrees.'

Thieves stole radioactive pipes

NEW DELHI, India (UPI)-A plastic pipe carrying radioactive waste from India's plutonium plant broke and contaminated several acres of land three to four years ago, the Press Trust of India News Agency recently disclosed.

The news agency also revealed other incidents of nuclear contamination. In one case, thieves stole radioactive pipes and sold them for scrap, and in another an employee attempted to steal radioactive gold.

The agency, quoting "highly placed sources" in the Department of Atomic Energy, said the most serious contamination occurred when radioactive liquids spilled from a pipe leading from the Trombay atomic complex near Bombay.

Health physicists noticed high radioactivity in the area and traced it to the leakage in the broken pipe.

"THE WHOLE AREA of three acres was dug up in a big earth-moving operation and the earth was dumped into the sea," the agency said.

In another_contamination incident, a gang of thieves stole several tons of

radioactive aluminium pipes and sold it in the Bombay market as scrap. When the theft was discovered, scientists armed with gieger counters tracked down some of the aluminium pipes in the Bombay scrap market.

"To this day no one knew how much of the contaminated material was in circulation or about the extent of hazard it caused to those who handled it," one

official was quoted as saying. The other case of contamination also involved theft. A worker stole highly contaminated gold and hid it in his clothes while going home. The worker, who

was heavily contaminated, was detected by geiger counters. The news agency said Trombay's plutonium plant was shut down four years ago because the "entire place including doors and handles were contaminated with

THE PLANT PROVIDED the plutonium for India's first, and so far the only, underground nuclear blast in May 1974. The plant has not been working since

"The process of decontamination is practically complete," one official said.

Business India, a prestigious publication by an Indian industrial house, recently reported 11,000 people working in the Indian nuclear plants "have been exposed to excessive levels of radiation,"

The magazine published photographs of the feet of a worker at the Bhabha Atomic Research Center with scars from excessive exposure to radiation,
